#### Florida's Job Growth Rate Leads the Entire Nation

Governor Rick Scott announced on October 28 that Florida had the highest annual private-sector job growth rate of any other state in the nation. Over the year in September, Florida added 252,400 new private-sector jobs, raising Florida's private-sector job growth rate to 3.6 percent. Florida's manufacturing industry also led the nation in job gains over the year in September, adding 15,300 new jobs. Governor Scott said, "Florida's strong job growth has consistently outpaced our top competitor states, including Texas, California and New York, and last month our job growth rate outpaced the entire nation. This great news is sending a message across the country that Florida is the best place for businesses to grow and create new opportunities. By creating a business-friendly environment and cutting taxes, we have been able to diversify our economy and put Florida on track to becoming first for job creation." #### Broward Job Growth Continues Strong Trend

Broward County's job report indicated a 4.6 percent unemployment rate in September 2016. This is a decrease of 0.3 percentage points from the year ago rate of 4.9 percent. Nonagricultural employment increased by 35,400 jobs (+4.4 percent) over the year, with an employment of 832,900 in the Ft. Lauderdale-Pompano Beach-Deerfield Beach MSA (Broward County). The region's jobless rate was 0.4 percentage point lower than the state rate (5.0 percent). Out of a labor force of 1,025,412 there were 46,755 unemployed Broward County residents.

"Broward County's robust job growth of 35,400 nonagricultural jobs over the last year continues to affirm the strength we are seeing in the economy," said Greater Fort Lauderdale Alliance President and CEO Bob Swindell. "Our employment growth rate of 4.4% and the variety of jobs added in numerous sectors puts us among the leaders in the state in job creation." To read more, please <u>click here</u>

The Greater Fort Lauderdale Alliance, Broward County's official public/private partnership for economic development, reported at its 2016 annual meeting on Thursday, October 20 that it helped attract 20 new company relocations and expansions during its 2015-16 fiscal year that ended September 30. This resulted in 2,646 new high-value jobs, 943 retained jobs and \$210 million in new capital investment... The Alliance reported that over the past decade, the Alliance, working with Broward County, CareerSource Broward and local municipalities, helped businesses create or retain more than 25,000 direct jobs that are estimated to have generated through direct, indirect and induced effects total employment of more than 55,000 jobs resulting in \$2.1 billion in annual personal income and \$11 billion in annual economic impact.
