## Greater Fort Lauderdale Alliance 2014 Annual Broward County Economic Development Activity Report

\$911,056 for Fiscal Year 2014 (October 1, 2013 – September 30, 2014).

### 4. The amount of funds received from private investors.

\$1,882,569 for Fiscal Year 2014.

### 5. Administrative costs of the EDO.

\$561,880 for Fiscal Year 2014.

**6. The number of businesses assisted by the EDO and the type of assistance provided.**

In Fiscal Year 2014 (October 1, 2013 through September 30, 2014), the Alliance assisted more than 400 companies. 176 local businesses were assisted in one or more of the following areas, which are provided as examples: Site Selection, Permitting/Licenses, Employee Relocation Services, Research & Market Analysis, Business Contacts & Referrals, General Community Information, Enterprise/Empowerment Zone Benefits, Procurement of Financing, State and Local Incentives (Qualified Target Industry (QTI) Tax Refund, Targeted Job Incentive Fund (TJIF), Brownfield Bonus and Manufacturing Sales Tax Exemption, Labor/Training Programs, such as the Quick Response Training (QRT) and Incumbent Worker Training (IWT). This resulted in 5,320 retained jobs.

In Fiscal Year 2014, the Alliance assisted 21 companies in establishing new and/or expanding existing operations in Broward County. Examples of assistance provided to these companies included the areas listed above.

The Greater Fort Lauderdale Alliance (The Alliance) considers a company to be an active project if the company is in a targeted industry sector, is considering Broward County as a place to locate or expand its operations and will be creating new jobs and committing new capital into the area.

A project is considered completed once all Alliance services are provided and the company acknowledges receiving those services and certifies the expected level of new job creation and new capital investment being made in Broward County.

**7. The capital investment of businesses who have been assisted by the EDO.**

The total capital investment of the 21 companies assisted by the Alliance in Fiscal Year 2014 is \$267,810,000.

**8. The foreign investment of businesses who have been assisted by the EDO.**

In Fiscal Year 2014, the Alliance assisted 5 international companies in establishing or expanding their operations in Broward County. The total foreign investment of those companies is \$32,300,000.

**9. The number of new direct jobs as a result of a business being moved into the area or expanding in the area due to the assistance of the EDO.**

A total of 1,412 new direct jobs will be created over a period of three years by the 21 companies that are establishing new and/or expanding existing operations in Broward County in Fiscal Year 2014.

**10. The number of jobs retained.**

In Fiscal Year 2014, in addition to the 1,412 new direct jobs created, the Alliance assisted in retaining 5,320 jobs in Broward County.

**11. The type of incentives that the EDO has successfully assisted businesses in receiving.**

In Fiscal Year 2014, the Alliance assisted companies in obtaining one or more of the following State and Local Incentives; the Florida Qualified Target Industry (QTI) Tax Refund, Governor's Quick Action Closing Fund (QACF), High Impact Performance Incentive (HIPI), Economic Development Transportation Fund, Broward County job growth incentives and local municipal incentives.

**12. Any additional information that would show an economic benefit to the local government as a result of the efforts of the EDO.**

From 2007 to 2014, the Alliance, working with its members, Broward County and other partners helped create or retain 20,288 direct jobs that are estimated to generate through direct, indirect and induced effects total employment of approximately 44,600 jobs in Broward County and 7,987 jobs elsewhere in Florida, \$8.8 billion in annual economic impact in Broward County and \$1.6 billion in annual personal income in Broward County.
